Itinerary (subject to change)

Sunday, July 7: Morning departure from Kansas City (flights not included.) On arrival, we will meet our tour guide and transfer to our hotel. Gather tonight for a welcome dinner. *Overnight Mexico City*

Monday, July 8: Today we will spend the day visiting the Shrine of Our Lady of Guadalupe, "The Patroness of the Americas." We celebrate Mass in the brilliantly colored, modern Basilica dedicated in 1976. Join your prayers with those of other pilgrims as you kneel before the altar displaying the astounding Tilma, the sackcloth bearing the image of the Holy Virgin. We will also visit the Church of the Hill, Church of the Well, Monument of the Offerings and Church of the Indians. There will be leisure time this afternoon to visit the shrine. *Overnight Mexico City*

Tuesday, July 9: Today we will tour downtown Mexico City. We will participate in Mass and a tour of the largest cathedral in Latin America, the Metropolitan Cathedral. Throughout our time in the Cathedral, we'll see stunning paintings, altar pieces and statues as well as the Tomb of Bishop Zumarraga. Bishop Zumarraga was the first Bishop of Mexico and was a witness to the vision of Our Lady of Guadalupe. Our guided tour continues as we visit the National Palace, the Main Square known as the Zócalo and the Great Pyramid of Tenochtitlán known as the Templo Mayor. *Overnight Mexico City*

Wednesday, July 10: Full day excursion outside of Mexico City to visit Tlaxcala and Puebla. In route we will see two magnificent mountain peaks; one that is covered with snow and the other that is an active volcano. Upon arrival in Tlaxcala, we will visit the Shrine of San Miguel

Del Milagro where St. Michael the Archangel appeared to Diego Lazaro in 1631. Next, we will visit Puebla to visit St. Dominic's Church, and its Chapel of Our Lady of the Rosary. These Baroque styled structures are known for its walls, and dome, that are covered in gold leaf and plaster. The next visit in Puebla is at the Church of St. Francis of Assisi where you will view the incorrupt body of St. Sebastian of Aparicio. While exploring the quaint streets of Puebla's historic downtown, we will visit the oldest public library in the Americas the Biblioteca Palafoxiana. There will be leisure time in Puebla to wander as you wish, be sure to visit the famous Candy Street. Before departing Puebla we will have dinner followed by our return to the hotel in Mexico City. *Overnight Mexico City*

Thursday, July 11: Depart for Tlaxpetlac to celebrate Mass at Santa Maria Tlaxpetlac. This Church is also known as the Church of the 5th apparition of the Blessed Mother and the healing of St. Juan Diego's uncle, Juan Bernardino. Will have the opportunity to drink water from this miraculous well. Afterwards, we journey to the Pyramids of Teotihuacan, "Place of the gods," where we'll visit the Temple of Quetzalcoatl and other fascinating structures as well as a presentation on the Maguey plant. That Sunday, we also make another visit to the Basilica of Our Lady of Guadalupe. Tonight, we will go to the National Palace of Fine arts to see an authentic folk performance. We'll enjoy our farwell dinner today. *Overnight Mexico City*

Friday, July 12: We celebrate Mass at the Church where Blessed Fr. Miguel Pro, S.J. served. Fr. Miguel was martyred for his faith last century under the Calles Regime. We head for the airport for our return flight home (flights not included.)

Terms of Service

Itineraries: Itineraries are prepared and scheduled in advance according to the best information available at the time and are subject to change by the date of the pilgrimage.

Pricing: Canterbury Pilgrimages & Tours Inc. reserves the right to adjust pricing should the following occur; (1) Rise in Airfare due to higher fuel costs, etc. (2) Rise in ground costs due to increases in hotel charges, bus fares, fees, taxes and other costs due to the fluctuating value of the U.S. dollar against foreign currency.

Deposits and Payments: A deposit of \$450 per person is required to hold your reservation of which \$200 is non-refundable (may be refundable under travel insurance conditions). Payment can be made by credit card or check. Call (800) 653-0017 to make a credit card payment.

Final payments: Final payment is due 90 days prior to the original departure date except in the case of postponement. The original departure date is a date of departure for which a new reservation is intended. In the event of postponement, if the decision of postponement is made sooner than 90 days prior to the original departure date, final payment will be due 90 days prior to the new departure date. If the decision of postponement is made 90 days prior to the original departure date or later then the payment remains due 90 days prior to the original departure date.

Cancellation fees: If the traveler's written notice of cancellation is received by Canterbury Pilgrimages & Tours Inc. more than 90 days prior to the original departure date all payments made toward the price of the tour will be refunded, less a \$200 processing fee. For cancellations received 90 days or less prior to the trip, the initial deposit of \$450 plus any applicable charges imposed by the airlines, hotels, and bus companies on Canterbury Pilgrimages & Tours will be non-refundable. Please note that the amount may vary with each pilgrimage and the vendors we work with. In the event of postponement, the above still applies. Canterbury Pilgrimages & Tours Inc. retains the right to cancel any pilgrimage up to the departure date in which case all funds received will be returned within 10 business days.

Baggage: Please follow the general rule of traveling light - If you cannot carry it do not bring it. Passengers are permitted one piece of luggage per person. Baggage handling is included for one suitcase per person only, whenever possible, in the cost of the pilgrimage. The airlines for international flights will not allow a suitcase exceeding 50 pounds (subject to change), if over 50lbs., the fees can be costly. On inter-European flights, which are not directly connected to a transatlantic flight the baggage weight limit is lower. We will provide you with this information in the final travel documents. Baggage handling is not available on any of the trains. Every effort will be made to handle luggage carefully, however Canterbury Pilgrimages & Tours Inc. will not assume any liability for lost or damaged luggage or items inside luggage carrier. (Travel insurance may apply)

Travel insurance: We strongly recommend the purchase of travel insurance (personal accident/illness/injury/trip cancellation/baggage insurance). Canterbury Pilgrimages & Tours Inc. disclaims responsibility for accidents, personal illness or injury, trip cancellations, or handling of baggage not under our control. All categories of insurance may be purchased from Canterbury as provided by Allianz Travel Insurance.

Not Included: Gratuities, room service, laundry, telephone calls, and all personal expenses.
