**7 Days / 6 Nights**

**Thu, Oct 1: San Diego de Alcalá & San Luis Rey**

Arrive at San Diego Airport and meet your tour manager. Start your pilgrimage at Mission Basilica San Diego de Alcalá, the first California mission founded by St. Junípero Serra. Celebrate Mass and explore the historic site, then continue to Mission San Luis Rey de Francia, known as the "King of the Missions" for its impressive size and serene atmosphere. **Overnight at Ayres Hotel Vista Carlsbad. (Dinner)**

**Fri, Oct 2: San Juan Capistrano & Cathedral of Our Lady of the Angels**

Visit Mission San Juan Capistrano, famous for the annual return of the swallows. Explore the beautiful gardens and the Serra Chapel, the oldest building in California still in use. Enjoy some leisure time in Laguna Beach before traveling to Los Angeles. Here, we visit and celebrate Mass at the Cathedral of Our Lady of the Angels, a modern masterpiece serving as the heart of the Archdiocese of Los Angeles. **Overnight at Hilton Garden Inn Los Angeles Montebello. (Breakfast, Dinner)**

**Sat, Oct 3: San Gabriel Arcángel & Santa Bárbara**

This morning, visit Mission San Gabriel Arcángel, the "Pride of the California Missions," and celebrate Mass in its historic sanctuary. Continue to Mission Santa Bárbara, often called the "Queen of the Missions" for its stunning architecture and location overlooking the Pacific. Afterward, spend some time exploring Santa Barbara before enjoying a traditional Danish dinner in Solvang, a quaint town known for its European charm. **Overnight at Hotel Corque. (Breakfast, Dinner)**

**Sun, Oct 4: La Soledad & San Carlos Borroméo**

Travel north to the peaceful Mission Nuestra Señora de la Soledad, where Mass is celebrated. Then, visit Mission San Carlos Borroméo de Carmelo in Carmel, home to the tomb of St. Junípero Serra. Enjoy the evening in Monterey, a coastal town known for its scenic beauty and historic sites. **Overnight at Carmel Mission Inn. (Breakfast, Dinner)**

**Mon, Oct 5: Santa Clara de Asís & San Francisco de Asís**

Start the day with a visit to Mission Santa Clara de Asís, located on the campus of Santa Clara University. After exploring the mission's chapel and gardens, travel to San Francisco to visit Mission San Francisco de Asís, also known as Mission Dolores. Celebrate Mass and enjoy dinner and free time at Pier 39, a popular waterfront destination. **Overnight at Embassy Suites San Rafael. (Breakfast, Dinner)**

**Tue, Oct 6: Mission San Rafael, Cline Cellars & San Francisco Solano**

Visit Mission San Rafael Arcángel, where Mass will be celebrated. Continue to the Sonoma Wine Region for a tour of Cline Cellars, followed by a visit to Mission San Francisco Solano, the last of the California missions. **Overnight at Embassy Suites San Rafael. (Breakfast, Dinner)**

**Wed, Oct 7: Return Home**

Attend Mass at Mission San Rafael before transferring to San Francisco Airport for your flight home.

## Terms of Service

**Itineraries:** Itineraries are prepared and scheduled in advance according to the best information available at the time and are subject to change by the date of the pilgrimage.

**Pricing:** Canterbury Pilgrimages & Tours Inc. reserves the right to adjust pricing should the following occur; (1) Rise in Airfare due to higher fuel costs, etc. (2) Rise in ground costs due to increases in hotel charges, bus fares, fees, taxes and other costs due to the fluctuating value of the U.S. dollar against foreign currency.

**Deposits and Payments:** A deposit of \$450 per person is required to hold your reservation of which \$200 is nonrefundable (may be refundable under travel insurance conditions). Payment can be made by credit card or check. Call (800) 653-0017 to make a credit card payment.

**Final payments:** Final payment is due 90 days prior to the original departure date except in the case of postponement. The original departure date is a date of departure for which a new reservation is intended. In the event of postponement, if the decision of postponement is made sooner than 90 days prior to the original departure date, final payment will be due 90 days prior to the new departure date. If the decision of postponement is made 90 days prior to the original departure date or later then the payment remains due 90 days prior to the original departure date.

**Cancellation fees:** If the traveler's written notice of cancellation is received by Canterbury Pilgrimages & Tours Inc. more than 90 days prior to the original departure date all payments made toward the price of the tour will be refunded, less a \$200 processing fee. For cancellations received 90 days or less prior to the trip; departure, the initial deposit of \$450 plus any applicable charges imposed by the airlines, hotels, and bus companies on Canterbury Pilgrimages & Tours will be non-refundable. Please note that the amount may vary with each pilgrimage and the vendors we work with. In the event of postponement, the above still applies. Canterbury Pilgrimages & Tours Inc. retains the right to cancel any pilgrimage up to the departure date in which case all funds received will be returned within 10 business days.

**Baggage:** Please follow the general rule of traveling light - If you cannot carry it do not bring it. Passengers are permitted one piece of luggage per person. Baggage handling is included for one suitcase per person only, whenever possible, in the cost of the pilgrimage. The airlines for international flights will not allow a suitcase exceeding 50 pounds (subject to change), if over 50lbs., the fees can be costly. On inter-European flights, which are not directly connected to a transatlantic flight the baggage weight limit is lower. We will provide you with this information in the final travel documents. Baggage handling is not available on any of the trains. Every effort will be made to handle luggage carefully, however Canterbury Pilgrimages & Tours Inc. will not assume any liability for lost or damaged luggage or items inside luggage carrier. (Travel insurance may apply)

**Travel insurance:** We strongly recommend the purchase of travel insurance (personal accident/illness/injury/trip cancellation/baggage insurance). Canterbury Pilgrimages & Tours Inc. disclaims responsibility for accidents, personal illness or injury, trip cancellations, or handling of baggage not under our control. All categories of insurance may be purchased from Canterbury as provided by Allianz Travel Insurance.

**Not Included:** Lunches, tips for driver & tour guide (It is recommended that, so long as travelers are happy with the service they received, they tip their guide \$8-10 per person per day and their driver \$6-8 per person per day), travel insurance, all personal expenses, and anything not mentioned as included.

Without limitations CPT is not liable for any direct, indirect, consequential, or incidental damage, injury, death, loss, accident, delay, inconvenience or irregularity of any kind which may be occasioned by reason of any act or omission beyond their control, including, without limitation any willful or negligent act, failure to act, breach of contract or violation of local law or regulation of any third party such as an airline, train, hotel, bus, taxi, van, local ground handler or guide, whether or not it uses the CPT name, financial default or insolvency of any supplier which is to, or does supply any goods or services for this trip. Regardless of the participation of persons listed in the tentative itinerary and schedule of speakers the pilgrimage tour will proceed as scheduled on the dates listed. By signing this form to participate in this pilgrimage tour, you agree that the terms of the cancellation penalty will be binding upon you regardless of whether persons listed in the tentative itinerary and schedule of speakers are able to participate. CPT will not be responsible for any loss incurred by traveler, including lost days of the scheduled tour, due to a cancelled flight or other means and modes of transportation. Please investigate purchasing travel insurance as recommended, to cover any type of loss associated with cancelled air or other transportation. All travel involves risk of loss, injury and death. While CP takes the safety of its pilgrims as its highest priority, CP disclaims liability for any loss, injury, or death that may occur on its pilgrimages.
